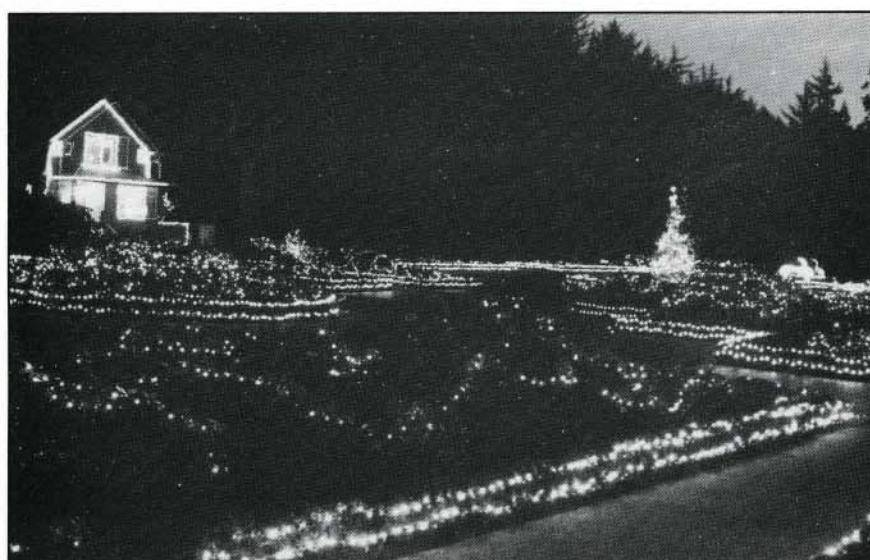

I would like to welcome new board members who were elected at our annual meeting September 10th. Bob and Doris Emmett will share one position and Georganna Casey will hold another. All three have volunteered in the Gift and Information Center and for the Holiday Lights event. I look forward to working with these enthusiastic and creative board members.

This is our fifth year of Holiday Lights at Shore Acres and this year is special. Holiday Lights '91 kicks off a two year celebration for the 50th year of Shore Acres State Park. *The official golden anniversary of the park is December 10, 1992.*

This year is special for another reason also. State parks' staff assisted by work center crews and volunteers have begun installation of more than 4,000 feet of additional underground wiring. This second phase brings the total amount of wire installed in the garden to more than four (4) miles. Seventeen new service outlets will be installed around the Oriental pond. This will enable the Friends to display the first phase of garden light scaping during the Holiday Lights this December.

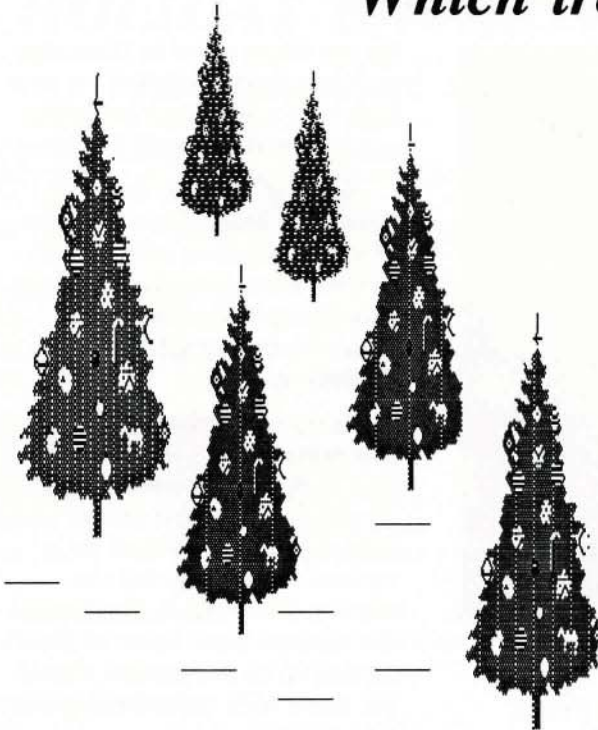
We are excited about Holiday Lights '91. More outdoor Christmas trees, new lights sculptures, accents of solid color lights, a new theme for the garden house, and as always, all of the wonderful volunteers, supporters, and state parks' staff who make it possible.

GARDEN NOTES

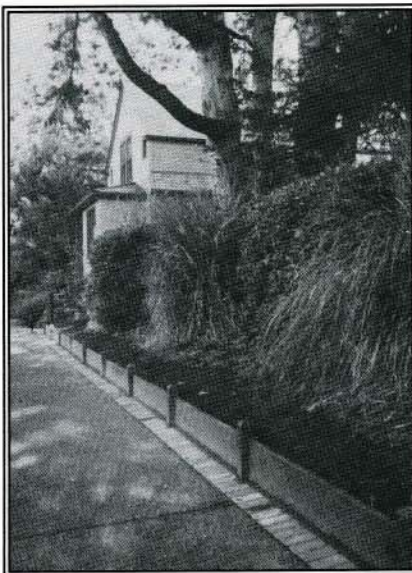

Believe it or not, gardeners are just like normal folks in most respects -- especially when it comes to cussing and discussing the weather and its effects on gardens. You have to admit we've had an interesting few months meteorologically.

With all the fog, clouds, and rain in May and June, everybody thought that summer would never come. Then during our September-October dry spell we thought it would never leave.

Add to all this climatic uncertainty little extras like a seeming national convention of porcupines in the rose garden and you wonder if anything could survive, let alone bloom or grow well.

Yet, despite all the problems, pests and pitfalls there was some pretty neat stuff going on. The water-lilies looked really superb, cosmos bloomed like champs, and despite a dismally slow start combined with a seemingly perverse desire on their part to toy with our emotions, the dahlias finally did come out and looked pretty darn fine.

Ed's show is syndicated in various stations across the country (Channel 2, Portland is the nearest one I know of that carries it) so the garden should get some wide-spread recognition.

So much for a review of things past -- the watchword in the garden is Christmas "yet to come" and it is coming soon. New, improved, bigger and better -- need we say more? Probably not, except to say come on down, bring a friend and enjoy Holiday Lights at Shore Acres 1991.

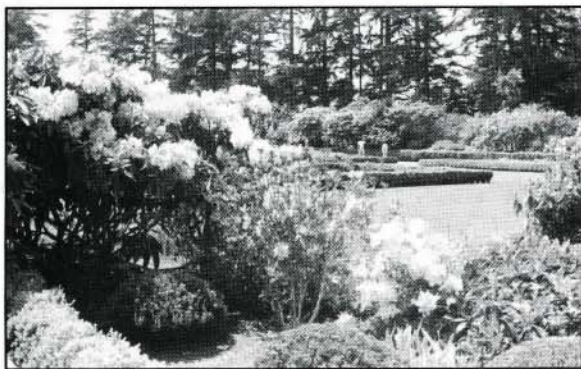
LOOKING BACK . . . highlights of the last five years

In 1985 the state of Oregon passed legislation to enable private, non-profit cooperatives to work with state parks. Their mission: *to provide educational and interpretive services to state parks and their visitors.*

On December 4, 1986, an organizational meeting of the Friends of Shore Acres was held at SWOCC. John Garner was elected chairman of the board of directors, which included John Bergen, George Guthrie, Marty Giles, John Garner, Dick Hansen, Tony Mason, and David and Shirley Bridgham. Also at the meeting were Andy LaTomme, Karen Wuethrich, Ron Hjort and Mike Bodkin. Those attending contributed one dollar each and Mike Bodkin agreed to file incorporation papers for the Friends.

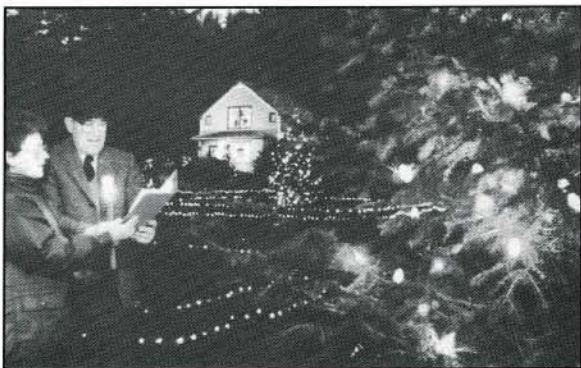
Early goals included improvement in garden plant identification and signs; new brochures and slide shows; replacement of plants and the former fountain; interpretive displays for Shell Island; interpretive display for the lighthouse viewpoint; a new trail map brochure; and a visitor center.

1987 - The Friends provided a series of intertidal walks at Cape Arago and garden walks at Shore Acres. Three annual spring and summer activities were established - Pond cleaning in March, Rhododendron Sunday on Mother's Day and Rose

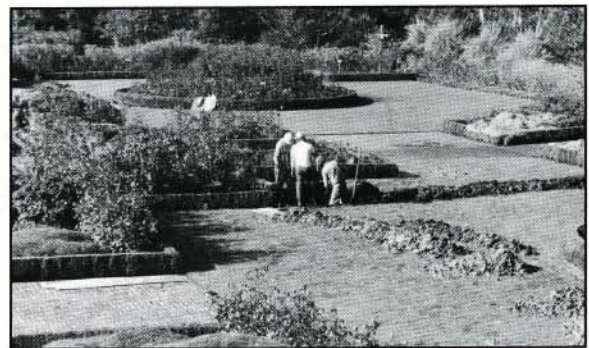


Sunday on Father's Day. The first newsletter was published in November.

One topic of discussion was night lighting in the garden. As a first step the Friends embarked on an ambitious adventure. Using temporary power poles and dozens of extension cords, volunteers strung 6,000 miniature white lights in the garden. Christmas at Shore Acres '87 drew 9,000 visitors and became an *instant community tradition.*



1988 - It was clear that permanent underground wiring was needed. Following plans engineered by Ed Riley and Tom Kyle, members of the Friends,



park personnel, and electricians Dave West, Tom Stemmerman and George Jones installed three miles of wire. It was completed during November rainstorms - just in time for the holiday season. Parking lot lights were installed and the expanded display of 12,000 lights drew 20,000 visitors from 38 states and 16 countries.



1989 - The Gift and Information Center opened, the Friends sold raspberry sundaes at the summer garden concert and state parks celebrated a 60th anniversary. A new brick walkway installed next to the garden house, gave direct access to the garden and the lights project expanded to 25,000 lights. About 35,000 visitors (from 153 Oregon cities, 43 states, 17 countries and 6 Canadian provinces) enjoyed the lights, the entertainment, a new theme in the garden house and the traditional hot cider and homemade cookies. >>>

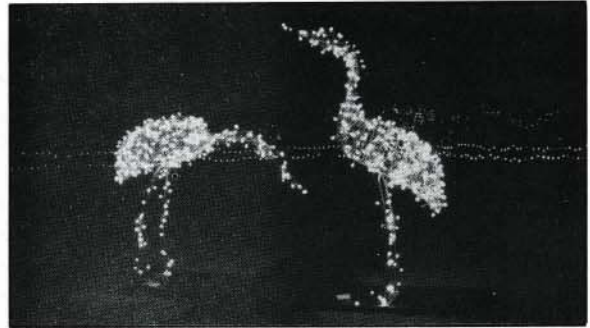
1990 - As the number of members, volunteers and supporters grew, the board planned for a very busy year. Volunteers from the Bureau of Land Management helped with the annual pond cleaning



and the Gift and Information Center expanded its inventory in anticipation of summer. The Friends helped the U.S. Coast Guard celebrate its 200th anniversary and were successful in securing five matching grants from Oregon State Parks. New plant identification markers were installed in the



garden and a slide program, The Shore Acres Story, was shown to visitors at the garden house. For the first time, local businesses and organizations were asked for lights pledges to expand the holiday lights. A successful campaign resulted in more than 50,000 lights for Holiday Lights and Open House '90. Several organizations decorated the large outdoor



Christmas trees, new lights sculptures were displayed, and the Oregon Highway Division installed *holiday lights* highway signs provided by Sunset Bay District. In spite of frigid weather, 45,000 visitors came from 142 Oregon cities, 46 states, 24 countries and 6 Canadian provinces. Comments ranged from "awesome" to "just beautiful, so glad we stayed the extra days to enjoy." Tricia and John Shreck won the first *ultimate bed and breakfast*, which entitled them to stay overnight in the garden house New Year's Eve.



1991 - In addition to regular activities, the living history grant project was completed and the Gift and Information Center was open from May through October (with plans to be open in December). Another successful lights pledge campaign will allow for expansion to more than 75,000 holiday lights in December. And watch for completion of the first phase of permanent light-scaping in the Oriental pond area of the garden.
