How Friends of Shore Acres Happened

In 1986, the Communication Arts Group at Southwestern Oregon Community College decided to tell the story of Shoreacres and Shore Acres State Park by creating a multi-image slide show to be shown at the 5th annual Multi-Image Festival in September. After the Festival, Shirley Bridgham asked Andy La Tomme, manager at Shore Acres State Park, if the park wanted a copy. He said yes. Not long after, Andy asked Shirley and her husband David if they would like to help start a Friends group – a non-profit corporation in association with state parks. They said yes.

An organizational meeting was held on December 4, 1986 at 7:30 pm in Room 12 of Sumner Hall on the campus of Southwestern Oregon Community College. In attendance were Andy La Tomme, John Bergen, Mike Bodkin, David and Shirley Bridgham, John Garner, Marty Giles, George Guthrie, Dick Hansen, Ron Hjort, Tony Mason, and Karen Wuethrich. On that important night, Friends of Shore Acres, Inc. In cooperation with Shore Acres State Park began a long journey of success.

The Shore Acres Story was shown in slide format to thousands of visitors for years, then transferred to VHS tape for easier showing. In 2006, it was transferred to DVD. In 2013, it was transformed again, this time with additional photos courtesy of Caitlin Day, James Mc Dermott, Sunset Bay State Park and the Coos Historical and Maritime Museum. Special thanks goes to Phillip Bridgham for rescuing the original sound track.

The program is about Asa Meade Simpson and his son Louis Jerome and the history of the magnificent estate that Louis called Shoreacres. It continues with what Shore Acres State Park was like in 1986 when the slide show was created. ■

Note from David Bridgham - September 2014

The following pages (and Albums) are a chronology of the efforts of Friends of Shore Acres, Inc., but even more than that, tell the tale of the enormous support that the Friends have enjoyed from our regional communities.

This was a movement whose time had come. The Oregon State Legislature had passed "Enabling" Legislation allowing non-profit 501(c)3 organizations to adopt a specific State Park to provide educational and interpretive services to its visitors. Well that's the dry legislative speak for find a core user group that loves that park and let it nurture and care for it.



Shore Acres State Park, 13 miles from town, is the touchstone that we all bring our friends and visitors to when we want to show off the beauty of the Oregon south coast. There was a built-in and pent-up desire to shower this special place with community pride and needed TLC. Outreach to our communities started with the planning sessions with FOSA Board members and volunteers. Dreaming of what could be, planning on now and the future.

Holiday Lights at Shore Acres is a night time interpretation of the formal English style gardens and the reflecting pond at the oriental garden. Historically, the original Simpson mansion built on the bluff at the stone wall, was a Christmas present to Louie Simpson's wife Cassie. From the very first lighting event we recognized the importance to the communities to open the Garden House for our visitors and start building traditions. After 27 annual lightings it thrills me to hear from adults with their young family when they tell us they came to see the lights as kids and now they're bringing their families to grow the tradition.

An important cornerstone to the Holiday Lights tradition is the consistency of our focus on major themes. We have stayed true to who we are and where we're at, interpreting the gardens with flower-lights, sculptures that are inspired by what's found in the gardens as well as many marine related sculptures. The Garden House is beautifully decorated with an old time (Simpson era) theme that fits this historic gardener's cottage.

There are those certainties in life - like the tide at our ocean's shore, the Bay and its tributaries - migrating geese, and the Holiday Lights at Shore Acres. When I see or hear a migrating flock of Canadian Geese I get an itch I can only scratch by stringing lights at Shore Acres.

You will see as you turn these pages that the secret sauce has always been to engage our community, give credit and ownership where deserved, and always try to improve this place that we all love. ■

FRIENDS OF SHORE ACRES ORGANIZATIONAL MEETING MINUTES

A meeting was held on December 4, 1986 at 7:30 pm in room 12 of Sumner Hall on the campus of Southwestern Oregon Community College. In attendance were Andy La Tomme, John Bergen, George Guthrie, Karen Wuethrich, Marty Giles, Ron Hjort, Mike Bodkin, John Garner, Shirley Bridgham, David Bridgham, Dick Hansen and Tony Mason. Andy La Tomme opened the meeting by giving background information about the establishment of non-profit corporations in association with state parks.

Mike Bodkin reviewed the legal steps necessary to establish a corporation and to certify it as tax-exempt under federal and state laws: fees to be paid, legal liability of corporation members and the formation of an initial board of directors.

Discussion followed on the details of the above presentations. The group agreed that a preliminary date of June, 1987 was a goal for establishing the tax-exempt status of the organization and that the group should forego any solicitation of funds until this status has been obtained.

Those present introduced themselves to the group and completed a sign-up sheet with their names and addresses. Each person was asked if he or she desired to serve on the initial board of directors. All except Andy La Tomme, Ron Hjort, Karen Wuethrich and Mike Bodkin responded "yes."

Some discussion followed about the number of state park employees to be allowed to serve on the board at any one time. It was generally agreed that no more than 1/4 of the board should be composed of state park employees, however formal action on this was deferred until bylaws are adopted. It was agreed that the Sunset Bay State Park district manager would serve as a non-voting member of the board. There was some discussion about this and it was understood and agreed that the group would not undertake any projects without the approval of the district park manager or his designee.

Nominations were opened for chairman. Dick Hansen and John Bergen were nominated and declined. John Garner was nominated and unanimously elected. He conducted the balance of the meeting.

A motion to name the organization the "Friends of Shore Acres, Inc," was proposed, seconded and passed.

Mike Bodkin was named to act as legal agent for the Friends of Shore Acres (hereafter referred to as the "Friends") and was thanked for his work thus far. Discussion followed regarding the purposes of the Friends as required for the incorporation papers.

Mike Bodkin stated that he would use wording from a similar organization's application and that he expected the incorporation papers would be returned by the next meeting.

It was decided the scope of the organization would be discussed when bylaws were presented for adoption at a later meeting.

There was discussion about membership in general, voting vs non-voting membership and graduated membership fees. Action on this was deferred until a later meeting.

A collection was taken to cover the cost of the incorporation fee. A total of \$13.00 was collected from the group.

It was proposed and approved that Mike Bodkin act as initial incorporator for the Friends.

Additional discussion about the purpose of the Friends took place. It was felt that the purposes stated in the articles of incorporation should be broad enough to allow the group to participate in a broad range of activities, including physical development in the park.

The agenda for the next meeting was discussed. It was decided that bylaws and the setting of goals for the group would take up most of the meeting. The board was asked to be prepared to discuss possible goals and committee assignments for that meeting. Dick Hansen was selected to lead the discussion on bylaws.

Andy La Tomme was asked to bring a copy of his park's master plan to assist in coordinating the goals of the Friends with those of State Parks. He was also asked to prepare a draft set of bylaws, based on those used by existing cooperating associations, to be mailed to board members before the next meeting.

Andy La Tomme was asked to prepare a press release announcing the formation of the Friends with special mention of Mike Bodkin's contribution.

Karen Wuethrich was asked to prepare minutes of the meeting.

The date for a second meeting was set for January 13, 1987. Shirley Bridgham was asked to arrange for a meeting room at SWOCC. The suggestion was made that the board consider a fixed meeting date, e.g., the second Tuesday of each month. It was felt that this was a good idea, but no action was taken.

The meeting adjourned at 10:00 pm.

Deferral of day-use fee expansion recommended
03-61 For immediate release:

Oregon Parks and Recreation Department staff will recommend next week that its earlier proposal to increase the number of parks charging day-use fees be postponed indefinitely. The recommendation will be made September 25 at a regular meeting of the Oregon Parks and Recreation Commission.

Michael Carrier, director of the Oregon Parks and Recreation Department (OPRD), said the recommendation to defer is based on, "an improved financial outlook and the expressed public support for maintaining the existing fee system."

For two years, staff and commissioners of OPRD have examined expanding day-use fees. This study was driven by the wish to address the equity of charging day-use fees at some, but not all, parks and by the need to ensure long-term financial security for the department.

The present day-use fee system is not equitable because it does not spread the burden of day-use fees equally across the entire park system, Carrier said. "Therefore, there is justification for expanding the fee to additional parks. However, a business case for doing so, which existed when the study began, does not presently exist."

Carrier explained that recent actions by the Legislature have resulted in greater than expected financial security for OPRD in the next several years without the need to expand fees. He said the increase in recreational vehicle registration fees and anticipated additional Oregon Lottery revenues, "have significantly improved the department's financial picture."

Governor Ted Kulongoski praised the public input phase of the department's review of its fee program. "It gave OPRD an opportunity to educate visitors about how state parks are presently funded and allowed park patrons to express their views about how parks should be funded in the future. This has been helpful in reaching a conclusion about the matter of day-use fees, and it will also help the commission in the future as it seeks to guarantee a stable source of funding for the department," Kulongoski said. # # #

Interpretive panels, kiosk installed at Simpson Reef Overlook

The U.S. Fish and Wildlife Service, Friends of Shore Acres and the Oregon Parks and Recreation Department announced that new interpretive panels and a wayfinding kiosk have been installed at the Simpson Reef Overlook. From the overlook, located in Cape Arago State Park, visitors enjoy breathtaking views of Shell Island and Simpson Reef, part of Oregon Islands National Wildlife Refuge. Simpson Reef is one of the few places on the Oregon Coast where visitors can see thousands of marine mammals.

The recently reconstructed overlook is fully accessible for people with disabilities and has three permanent benches.

The interpretive development was a partnership between the Fish and Wildlife Service, Friends, and OPRD. The Friends contributed \$6,000 to the project, administered the contract, and assisted with design. The Wildlife Service contributed \$10,000 and assisted with design and fabrication. OPRD also assisted with design and is responsible for installation and maintenance. In addition, the Bureau of Land Management devised the original plans on which the final design of the parking lot was based.

"This project is a great example of what can happen when people work together for a common goal. The Simpson Reef Overlook is one of the best kept secrets on the Oregon Coast, maybe the West Coast and we (the Friends) are excited about telling

everyone about the new improvements that will make a trip out there even more worthwhile" said Shirley Bridgham, past president and board member of Friends of Shore Acres, Inc.

Larry Becker, assistant area manager for state parks on the South Coast said, "The construction of the overlook and the placement of the interpretive panels culminates a vision started in 1993 and is a major step toward addressing OPRD's 2014 goal of providing world-class interpretive opportunities to park visitors to the Sunset Bay-Cape Arago park complex.

One of the new interpretive panels provides visitors with tips on identify-

ing and locating the four species of pinniped (seals and sea lions) that regularly haul out on Shell Island. A second interpretive panel provides detailed information of the life history of the harbor seal, northern elephant seal, Stellar sea lion, California sea lion and California gray whale, species regularly seen from the Simpson Reef Overlook. The wayfinding kiosk will direct visitors to other sites within the vicinity where they can enjoy natural resources or historic places. For unparalleled views of Oregon's spectacular coastline and even rarer glimpses of its marine life visit Simpson Reef Overlook any day of the year.

"The installation of the interpretive

panels completes the overlook improvement project that was initiated in the spring of 2000," said Roy W. Lowe, project leader for the Oregon Coast National Wildlife Refuge Complex based in Newport. "Visitor experience at this site will now be greatly enhanced through learning about these amazing animals," Lowe said.

The U.S. Fish and Wildlife Service is the principal federal agency responsible for conserving, protecting and enhancing fish, wildlife and plants and their habitats for the continuing benefit of the American people. It manages

the 95-million-acre National Wildlife Refuge System, which encompasses 542 national wildlife refuges, thousands of small wetlands and other special management areas. It also operates 70 national fish hatcheries, 64 fishery resource offices and 81 ecological services field stations. The agency enforces federal wildlife laws, administers the Endangered Species Act, manages migratory bird populations, restores nationally significant fisheries, conserves and restores wildlife habitat such as wetlands, and helps foreign governments with their conservation efforts.

THE FINISHING TOUCHES WILL BE ADDED AND THE DOORS WILL OPEN TO THE NEW INFORMATION & GIFT CENTER JUST IN TIME FOR THE 17TH ANNUAL HOLIDAY LIGHTS.



Visitors to the 17th annual Holiday Lights at Shore Acres State Park will enter the formal gardens by way of a new pergola, thanks to funds from the Oregon Lottery and the Friends of Shore Acres. The passageway, with its lighted, white columns, replaces the redwood-deck version which was installed during the 1974 garden renovation.

The \$300,000 project, constructed by Laskey Clifton Corporation of Reedsport, consists of an octagon-shaped gazebo with three columned pergolas, an 800 square foot deck and a 1536 square foot Information and Gift Center. The gazebo and pergolas are reminiscent of structures that were present when Louis Simpson developed Shore Acres in the early 1900s.

The cedar shingled building with its gambrel roof-line and dormers is styled after Simpson's first mansion, which burned to the ground on July 4, 1921. It has up-to-date heating and energy-efficient technology, in addition to being fully accessible. It replaces a 576 square foot building which was used since 1985 as an Information and Gift Center by the Friends.

The Information & Gift Center (IGC) is open all year. This all-volunteer operation, managed by Lou and Sharon Kolkhorst, is a primary source of funding for many of the Friends' activities.

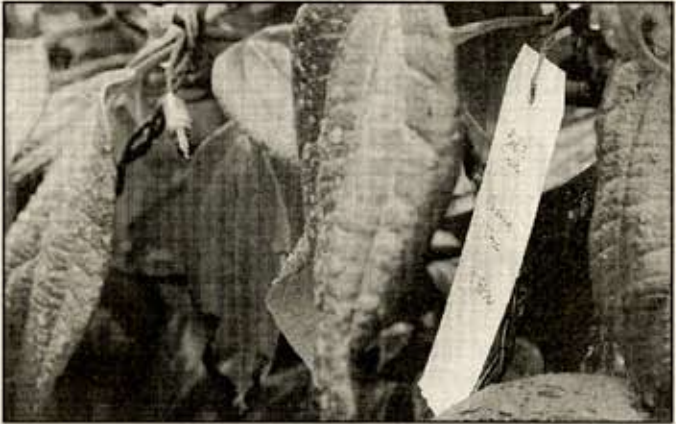

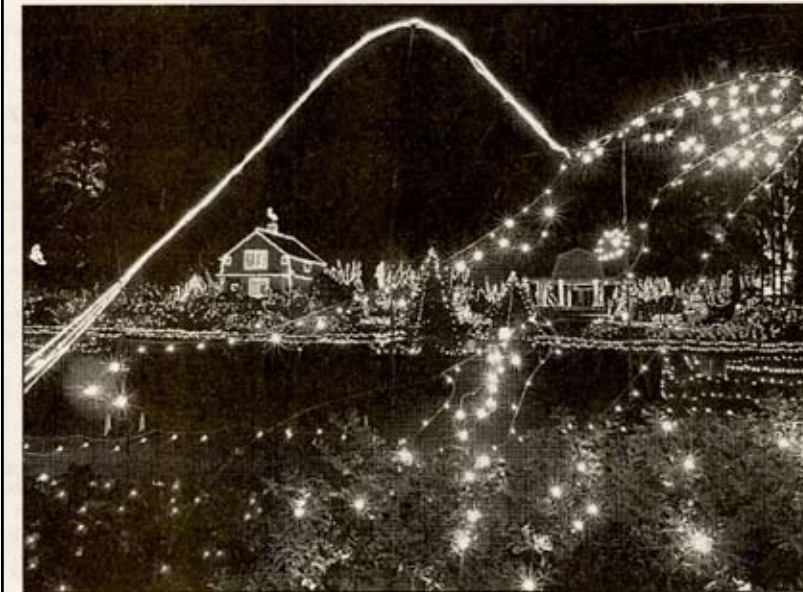

Holiday Lights

Annual event to include unveiling of new entrance

Visitors to the 17th-annual Holiday Lights at Shore Acres State Park will enter the formal gardens through a new pergola, a passageway reminiscent of one used by guests of estate owner Louis Simpson about a century ago.

Funded by Oregon Lottery dollars and the Friends of Shore Acres, the entryway, resplendent with its lighted, white columns, replaces a red-wood-deck structure that had served as the garden's entrance since 1974.

"We now have an entrance equal to the beauty of the gardens," said Park Manager Larry Becker. "We're very fortunate to have Parks and Natural Resources Fund support as well as a substantial donation from the Friends to make it happen."

The new entrance complex consists of an octagon-shaped gazebo with three adjoining columned pergolas, including the 30-foot entryway to the garden. An 800-square-foot deck and a 1,536-square-foot information and gift center complete the new look.

Products of a \$300,000 project, the structures are modeled after those present when Simpson developed Shore Acres in the early 1900s. Simpson was pioneer lumberman and shipping tycoon whose estate once occupied the land comprising both Shore Acres and Cape Arago state parks.

The cedar-shingled building now serving as the park's interpretive gift store is styled after Simpson's first mansion, which burned to the ground on July 4, 1921. Adorned with gambrel

roofline and dormers, the building has up-to-date heating and energy-efficient technology, and is fully accessible. It replaced a 576-square-foot structure used as an information and gift center by the Friends of Shore Acres since 1992.

"We are very excited to move into this beautiful expanded space," said Shirley Bridgham, one of the founders and current board member of the Friends group. She added that managers Lou and Sharon Kolkhorst plan to have the new center open by Thanksgiving. The Bay Area Chamber of Commerce Ambassadors has scheduled a ribbon-cutting ceremony at 4:45 p.m. on Friday, Dec. 5.

The old building was moved to nearby Sunset Bay State Park for use as a campground interpretive center by the park's Junior Ranger program, which offers outdoor educational activities for children age 6 to 12.

The new information and gift center will be open the same hours as the 39-night Holiday Lights exhibition — from 4 to 10 p.m. Nov. 28-Jan. 4, 2004. Beginning Jan. 5, the center will be open from noon to 4 p.m. through March 31.

Shore Acres is a day-use fee park. Visitors need to buy a \$3 per vehicle daily parking permit or show a current state park day-use pass (12-month or 24-month), a same-day state park campground receipt or an Oregon Coast Passport.

Storm slams South Coast

LIBBY — "It's a foot lower already," Anthony Atteberry said Sunday afternoon, wearing black rubber boots and carrying a Christmas tree through flood waters to his home on Red Dike Road.

Atteberry's home, like several others on the South Coast, was surrounded by water left from a storm that dropped a record 4.05 inches of rain on the region Saturday. It broke the 1946 record of 2.37 inches of rain for Dec. 13. Including Sunday's smattering of rain, this year's total so far is 57.87 inches — almost an inch lower than normal rainfall for the same time and about 8 inches more than last year, according to the National Weather Service.



Anthony Atteberry carries a Christmas tree to his house through flood waters Sunday afternoon. This flood wasn't as bad as last year, he said, when the waters were higher than his rubber boots and he had to carry his children out of the house and through the water.

Though slogging through water was a hassle, Atteberry said it wasn't as bad as last year. He and his family spent three days in a motel waiting for waters to recede. The water was higher than the tops of his boots, he explained.

The Coquille River flooded, turning valley fields into Winter Lake. Crews cleared debris from the bridge near Sturdivant Park in Coquille Sunday, allowing the river to flow freely again, while Highway 42S, Fishtrap Road and several of the smaller roads in the valley were under water.

The North Fork of the Coquille River crested at 37.14 feet early Sunday morning, more than 2 feet above flood stage. The South Fork crested at 42.61 feet around 5 a.m. Sunday, more than 4 feet above flood stage. Warnings Friday and Saturday indicated extensive damage to houses, farms and roads could be expected, along with moderate erosion along the banks of the North Fork.

The Siuslaw River near Mapleton also reached its flood stage of 18 feet, which, as the National Weather Service warned, could cause minor flooding of low-lying dairy land and some structures along the banks of the river.

As of this morning, a flood warning remained in effect for the Coquille River at Coquille and the warning for the South Fork at Myrtle Point had expired. The Coquille River should fall below flood stage by this evening, forecasters advise.

Sunday morning brought other weather to the coast region: a mix of thunderstorms, some rain, some hail and, very late Sunday night and early this morning, freezing temperatures and frost.

Storm-generated waves pounded the coastline Saturday, and the beaches were busy with storm watchers Sunday. At least

one surfer braved the elements Sunday afternoon at Sunset Bay.

"It's a good surf day," Spike Richardson said as he returned to his truck and began putting his surfboard away. Richardson said there were probably some better waves elsewhere but that the moderate waves at Sunset provide some easy fun.

Despite being pelted by heavy rain during the weekend, Pacific Power customers in Coos County was spared the power outages that plagued much of inland Douglas County, according to Joe Litzinger, regional community manager.

While more than 5,500 customers went dark Saturday night in Douglas County — with 3,000 still without power this morning — only "scattered outages" were reported in Coos Bay and none in the southern part of the county, Litzinger said.

"We only had outages to individual homes, at most five to 10 customers at a time," he said. "We didn't have a circuit or substation go out."

It was much the same story in Lakeside and Reedsport, where Douglas Electric Cooperative Inc. reported only a fraction of the outages that put as many as a third of its 9,000 customers in the dark countywide. According to company spokesman Todd Munsey, the few degrees that separated coastal temperatures from those inland forestalled the snow that elsewhere burdened — and snapped — trees and power poles.

"Except for a broken pole Saturday, we didn't have any outages in the Reedsport-Tenmile Lakes area," he said. "If (the problem) were wind," rather than snow, he added, "It would have been just the opposite."

Outages in Douglas County began about 5 p.m. Saturday and most were repaired by 10 p.m. Sunday.

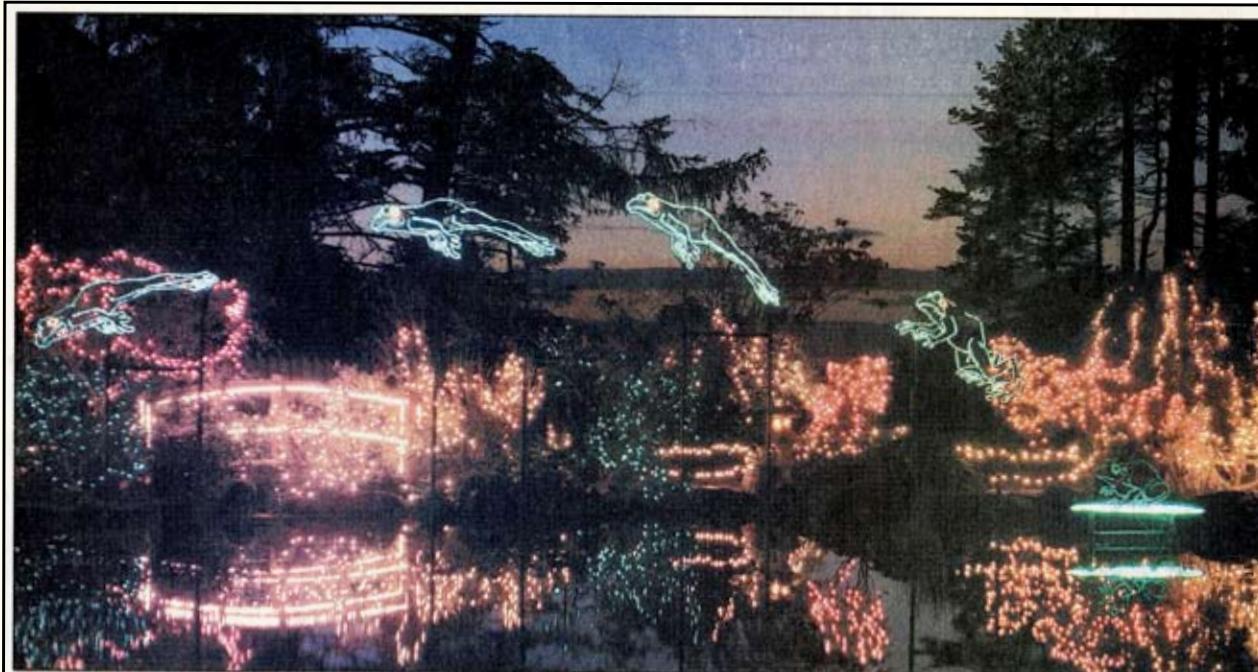
Meanwhile, the swollen creeks did provide for some amusement.

"It's one way we can find the kids' basketballs," Atteberry said, pointing across the road at water-filled ditch, where two basketballs had popped to the surface and were stuck in an eddy near a pasture. "They always pop up."

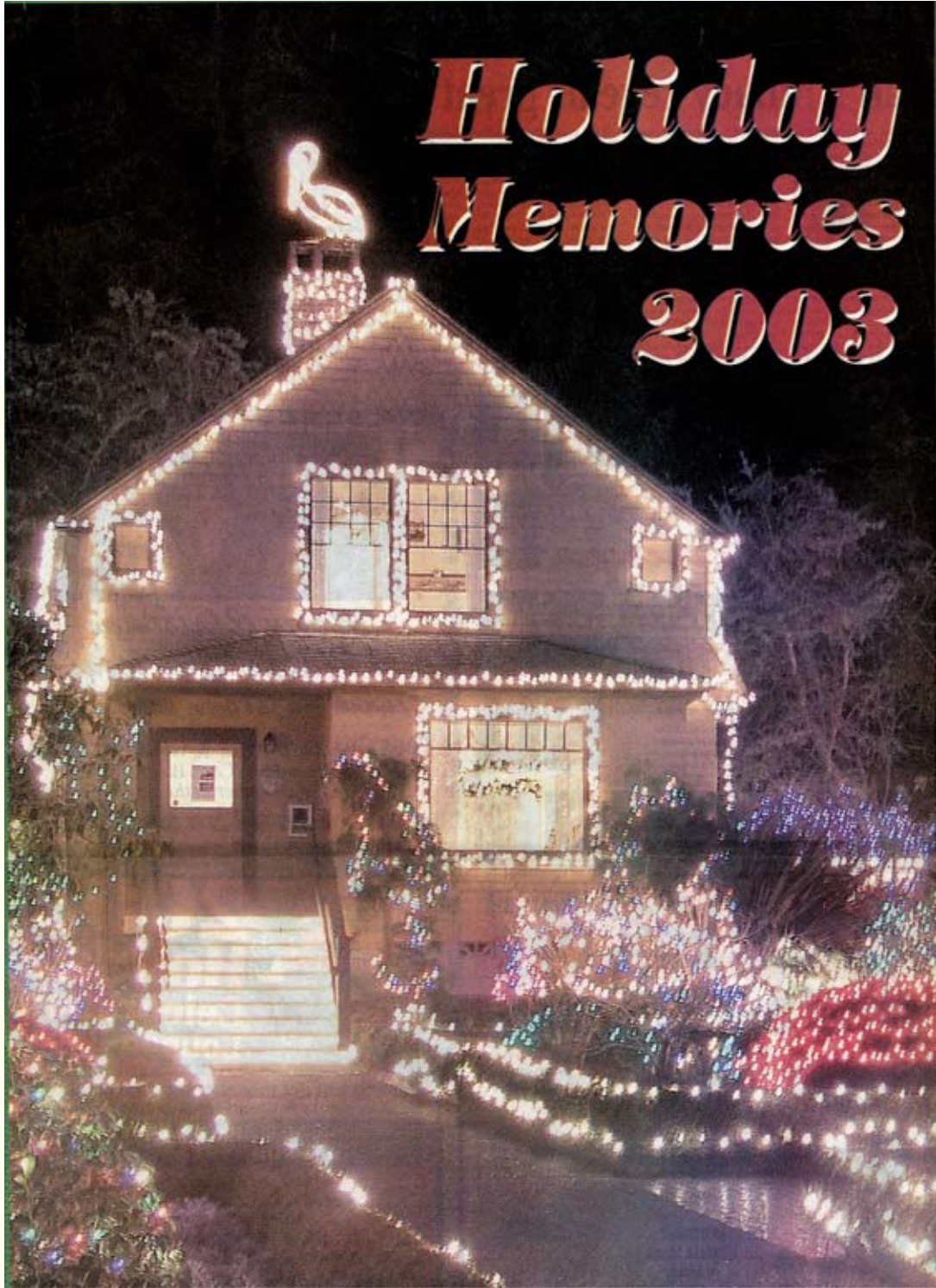

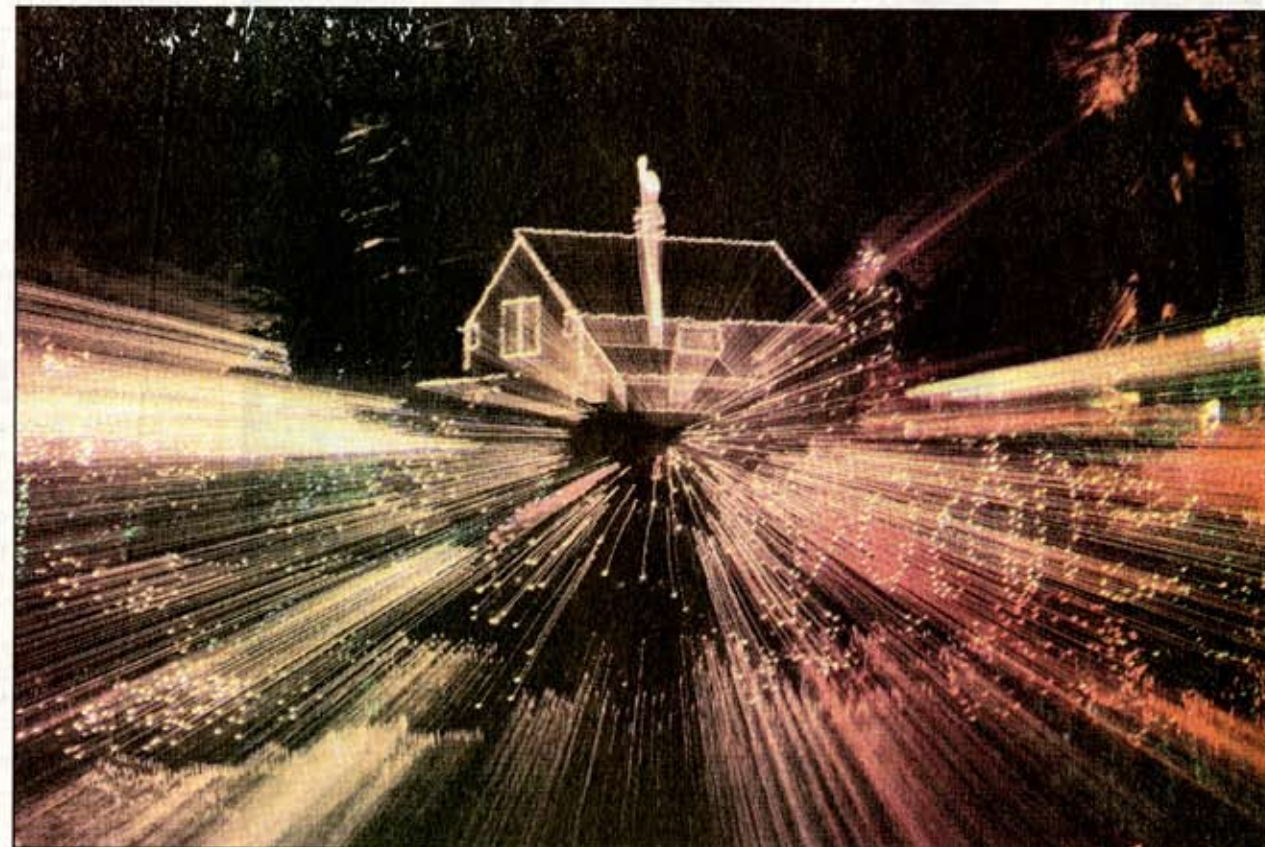

Vandals wreck interpretive signs

Visitors to the newly renovated Simpson Reef Overlook near Cape Arago State Park by Charleston this week likely enjoyed watching sea lions and harbor seals loafing on Shell Island, but they also witnessed the work of vandals.

"Somebody, some individuals, pried and damaged and took three of the interpretive signs," said Larry Becker, assistant area manager in Charleston for the Oregon Parks & Recreation Department.

The thefts occurred Monday night or Tuesday morning, leaving frustrated State Parks officials trying to figure out why anyone would want the signs and where they went. The displays informed the curious about the offshore animals frequenting and living in the skies and sea.

Becker said the signs were specially made to withstand the wind, rain and sun that beat the coastal overlook year-round. Each sign cost \$300 to \$400. The signs were new,

installed in October, he said, adding that the Coos County Sheriff's Office has begun an investigation.

The damage wasn't limited to the overlook. The same night, someone crashed a stolen vehicle into a large group of signs at Cape Arago State Park, shearing off the 6-inch-by-6-inch posts at the ground.

Vandalism isn't a rare occurrence at the park. Becker said from time to time, park officials find lawns damaged by tire cuts and paint or bullet holes on signs.

For now, park officials have filed a complaint with the Sheriff's Office. They are encouraging anyone who might have information about vandalism at either spot to share it with investigators.

"These signs were funded through project funds and grant money," Becker said. "Any time there's damage to a public facility, it costs everybody a little bit."

State Parks: How would you like to spend your days?

There are dozens of day-use sites and waysides provided by the state of Oregon. Several of the most popular of these places are:

■ Golden and Silver Falls State Natural

Area, a day-use site that contains over 157 acres and two waterfalls. Hiking trails take visitors through soothing green ferns and forest to the tops of both falls. It is located 24 miles north-

east of Coos Bay at the end of the road beyond the little community of Allegany. The road narrows and it is not advisable to take RVs there as the parking and turn-around areas are limited.

■ Shore Acres State Park, once the estate of lumber baron Louis Simpson, is located on high oceanside bluffs, and the gardens that he planted there are now beautifully maintained by the state. The park with its blooms and shrubs is popular for weddings. It is located 2 miles south of Sunset Bay State Park. The office number is (541) 888-3732.

■ Cape Arago State Park provides visitors with spectacular views of the ocean and the rugged coastline to the south, and has trails, sea coves and picnic areas. It is about two-and 1/2 miles south of Shore Acres State Park.

State parks located in Coos County that have camping facilities include:

■ William Tugman State Park, located along U.S. Highway 101 north of Lakeside on Eel Lake. It is a large park with groomed lawns, picnic and camping areas, a boat ramp (under 10 mph speed limit on the lake), swimming

area, yurts, lakeside hiking trails and a playground.

■ Sunset Bay State Park is a beautiful, sheltered cove located about three-and-1/2 miles south of Charleston. It is popular for water sports such as kayaking and has plenty of room for wading and swimming. There also is a wind-sheltered campground with developed sites, yurts and picnic areas near the beach. The office number is (541) 888-3732.

■ Bullard's Beach State Park is two miles north of Bandon, along the bay of the Coquille River and on the ocean beach. Bandon's well-photographed old lighthouse is located there. The park is large and has 92 sites with full hookups and over 100 other sites for camping. The office number is (541) 347-2209.
