## How Friends of Shore Acres Happened

In 1986, the Communication Arts Group at Southwestern Oregon Community College decided to tell the story of Shoreacres and Shore Acres State Park by creating a multi-image slide show to be shown at the 5th annual Multi-Image Festival in September. After the Festival, Shirley Bridgham asked Andy La Tomme, manager at Shore Acres State Park, if the park wanted a copy. He said yes. Not long after, Andy asked Shirley and her husband David if they would like to help start a Friends group – a non-profit corporation in association with state parks. They said yes.

An organizational meeting was held on December 4, 1986 at 7:30 pm in Room 12 of Sumner Hall on the campus of Southwestern Oregon Community College. In attendance were Andy La Tomme, John Bergen, Mike Bodkin, David and Shirley Bridgham, John Garner, Marty Giles, George Guthrie, Dick Hansen, Ron Hjort, Tony Mason, and Karen Wuethrich. On that important night, Friends of Shore Acres, Inc. In cooperation with Shore Acres State Park began a long journey of success.

*The Shore Acres Story* was shown in slide format to thousands of visitors for years, then transferred to VHS tape for easier showing. In 2006, it was transferred to DVD. In 2013, it was transformed again, this time with additional photos courtesy of Caitlin Day, James Mc Dermott, Sunset Bay State Park and the Coos Historical and Maritime Museum. Special thanks goes to Phillip Bridgham for rescuing the original sound track.

The program is about Asa Meade Simpson and his son Louis Jerome and the history of the magnificent estate that Louis called Shoreacres. It continues with what Shore Acres State Park was like in 1986 when the slide show was created. ■

## Note from David Bridgham - September 2014

*The following pages (and Albums) are a chronology of the efforts of Friends of Shore Acres, Inc., but even more than that, tell the tale of the enormous support that the Friends have enjoyed from our regional communities.*

*This was a movement whose time had come. The Oregon State Legislature had passed "Enabling" Legislation allowing non-profit 501(c)3 organizations to adopt a specific State Park to provide educational and interpretive services to its visitors. Well that's the dry legislative speak for find a core user group that loves that park and let it nurture and care for it.*



*Shore Acres State Park, 13 miles from town, is the touchstone that we all bring our friends and visitors to when we want to show off the beauty of the Oregon south coast. There was a built-in and pent-up desire to shower this special place with community pride and needed TLC. Outreach to our communities started with the planning sessions with FOSA Board members and volunteers. Dreaming of what could be, planning on now and the future.*

*Holiday Lights at Shore Acres is a night time interpretation of the formal English style gardens and the reflecting pond at the oriental garden. Historically, the original Simpson mansion built on the bluff at the stone wall, was a Christmas present to Louie Simpson's wife Cassie. From the very first lighting event we recognized the importance to the communities to open the Garden House for our visitors and start building traditions. After 27 annual lightings it thrills me to hear from adults with their young family when they tell us they came to see the lights as kids and now they're bringing their families to grow the tradition.*

*An important cornerstone to the Holiday Lights tradition is the consistency of our focus on major themes. We have stayed true to who we are and where we're at, interpreting the gardens with flower-lights, sculptures that are inspired by what's found in the gardens as well as many marine related sculptures. The Garden House is beautifully decorated with an old time (Simpson era) theme that fits this historic gardener's cottage.*

*There are those certainties in life - like the tide at our ocean's shore, the Bay and its tributaries - migrating geese, and the Holiday Lights at Shore Acres. When I see or hear a migrating flock of Canadian Geese I get an itch I can only scratch by stringing lights at Shore Acres.*

*You will see as you turn these pages that the secret sauce has always been to engage our community, give credit and ownership where deserved, and always try to improve this place that we all love. ■*

## FRIENDS OF SHORE ACRES ORGANIZATIONAL MEETING MINUTES

A meeting was held on December 4, 1986 at 7:30 pm in room 12 of Sumner Hall on the campus of Southwestern Oregon Community College. In attendance were Andy La Tomme, John Bergen, George Guthrie, Karen Wuethrich, Marty Giles, Ron Hjort, Mike Bodkin, John Garner, Shirley Bridgham, David Bridgham, Dick Hansen and Tony Mason. Andy La Tomme opened the meeting by giving background information about the establishment of non-profit corporations in association with state parks.

Mike Bodkin reviewed the legal steps necessary to establish a corporation and to certify it as tax-exempt under federal and state laws: fees to be paid, legal liability of corporation members and the formation of an initial board of directors.

Discussion followed on the details of the above presentations. The group agreed that a preliminary date of June, 1987 was a goal for establishing the tax-exempt status of the organization and that the group should forego any solicitation of funds until this status has been obtained.

Those present introduced themselves to the group and completed a sign-up sheet with their names and addresses. Each person was asked if he or she desired to serve on the initial board of directors. All except Andy La Tomme, Ron Hjort, Karen Wuethrich and Mike Bodkin responded "yes."

Some discussion followed about the number of state park employees to be allowed to serve on the board at any one time. It was generally agreed that no more than 1/4 of the board should be composed of state park employees, however formal action on this was deferred until bylaws are adopted. It was agreed that the Sunset Bay State Park district manager would serve as a non-voting member of the board. There was some discussion about this and it was understood and agreed that the group would not undertake any projects without the approval of the district park manager or his designee.

Nominations were opened for chairman. Dick Hansen and John Bergen were nominated and declined. John Garner was nominated and unanimously elected. He conducted the balance of the meeting.

A motion to name the organization the "Friends of Shore Acres, Inc," was proposed, seconded and passed.

Mike Bodkin was named to act as legal agent for the Friends of Shore Acres (hereafter referred to as the "Friends") and was thanked for his work thus far. Discussion followed regarding the purposes of the Friends as required for the incorporation papers.

Mike Bodkin stated that he would use wording from a similar organization's application and that he expected the incorporation papers would be returned by the next meeting.

It was decided the scope of the organization would be discussed when bylaws were presented for adoption at a later meeting.

There was discussion about membership in general, voting vs non-voting membership and graduated membership fees. Action on this was deferred until a later meeting.

A collection was taken to cover the cost of the incorporation fee. A total of \$13.00 was collected from the group.

It was proposed and approved that Mike Bodkin act as initial incorporator for the Friends.

Additional discussion about the purpose of the Friends took place. It was felt that the purposes stated in the articles of incorporation should be broad enough to allow the group to participate in a broad range of activities, including physical development in the park.

The agenda for the next meeting was discussed. It was decided that bylaws and the setting of goals for the group would take up most of the meeting. The board was asked to be prepared to discuss possible goals and committee assignments for that meeting. Dick Hansen was selected to lead the discussion on bylaws.

Andy La Tomme was asked to bring a copy of his park's master plan to assist in coordinating the goals of the Friends with those of State Parks. He was also asked to prepare a draft set of bylaws, based on those used by existing cooperating associations, to be mailed to board members before the next meeting.


Andy La Tomme was asked to prepare a press release announcing the formation of the Friends with special mention of Mike Bodkin's contribution.

Karen Wuethrich was asked to prepare minutes of the meeting.

The date for a second meeting was set for January 13, 1987. Shirley Bridgham was asked to arrange for a meeting room at SWOCC. The suggestion was made that the board consider a fixed meeting date, e.g., the second Tuesday of each month. It was felt that this was a good idea, but no action was taken.

The meeting adjourned at 10:00 pm.

The following is a report of significant activities & events affecting OPRD, Sunset Bay Management Unit and specifically Shore Acres State Park. If you have any questions or concerns regarding the projects and activities at Shore Acres or other parks in Sunset Bay's Management Unit, please contact George Guthrie at 541-888-3732, Dennis Lucas at 541-888-3778 ext. 23 or myself 541-888-3778 ext. 22.

**SHORE ACRES PROJECTS** - New ADA compliant path to the garden house • Thinning and reduction of the vegetation east and north of the large field. • Replacement of one primary sewage lift station pump. • Repair of the asphalt cut and control of the water that surfaces from winter rains • Larry will add supports to the undersea garden frame once it is installed. • Dennis Lucas is currently pursuing the installation of a booster pump station on the potable water line for Shore Acres and Cape Arago and also re-developing the non-potable water portion of the garden from Big Creek, Norton Creek or drilling a well. • Larry is working Nancy Nedemhofer of SHPO to get approval to either repair or replace the garden house windows. Nancy is advocating repair instead of replacement as the garden house is under review for historic status.

**MISCELLANEOUS INFORMATION** - The annual plan and the five-year agreement between FoSA and OPRD needs to be updated. • Larry and Dennis went to training on Non-Profit Cooperating Associations on October 5, 2004. They will schedule a time (after Holiday Lights) when they, Connie Bradley and the FoSA Board can review the legal and legislative responsibilities of the Cooperative Association and OPRD in administering the Agreement.

**UNIT PROJECTS** - William Tugman campground will have a complete electrical upgrade in March-May of 2005. • Sunset staff will remove hazard trees at Sunset Bay and William Tugman during November-December of 2004. • By May 2005 three more yurts will be installed at William Tugman, bring the total number of yurts to 16. • Sunset staff will install a septic tank in the overnight camp for the interpretive building.

**ODOT PROJECTS** - Johnson Rock has the contract for the re-alignment of the Cape Arago Hwy between Simpson Reef Overlook and Cape Arago State Park. • Bid documents are out for the repair and re-alignment of the highway at Norton Gulch.

**PARK PERSONNEL** - Tim Wood has been named the Director of OPRD. Tim was the Assistant Director in charge of field operations. That position is now open and the recruitment process has started. • Dave Esch, Sunset Bay MU Ranger, has announced his retirement effective December 31, 2004. • Retirements of Greg Foster in September (and transfer of his position to Harris Beach SP) and Dave Esch along with vacancy of Calum Stevenson's position while he is on developmental assignment and the long absence of Rob Kilmer for medical reasons has created a staff shortage for the MU. Karen Wuethrich and Dennis Maurer, Seasonal Ranger Aides, have been retained to help with park operation through the winter.

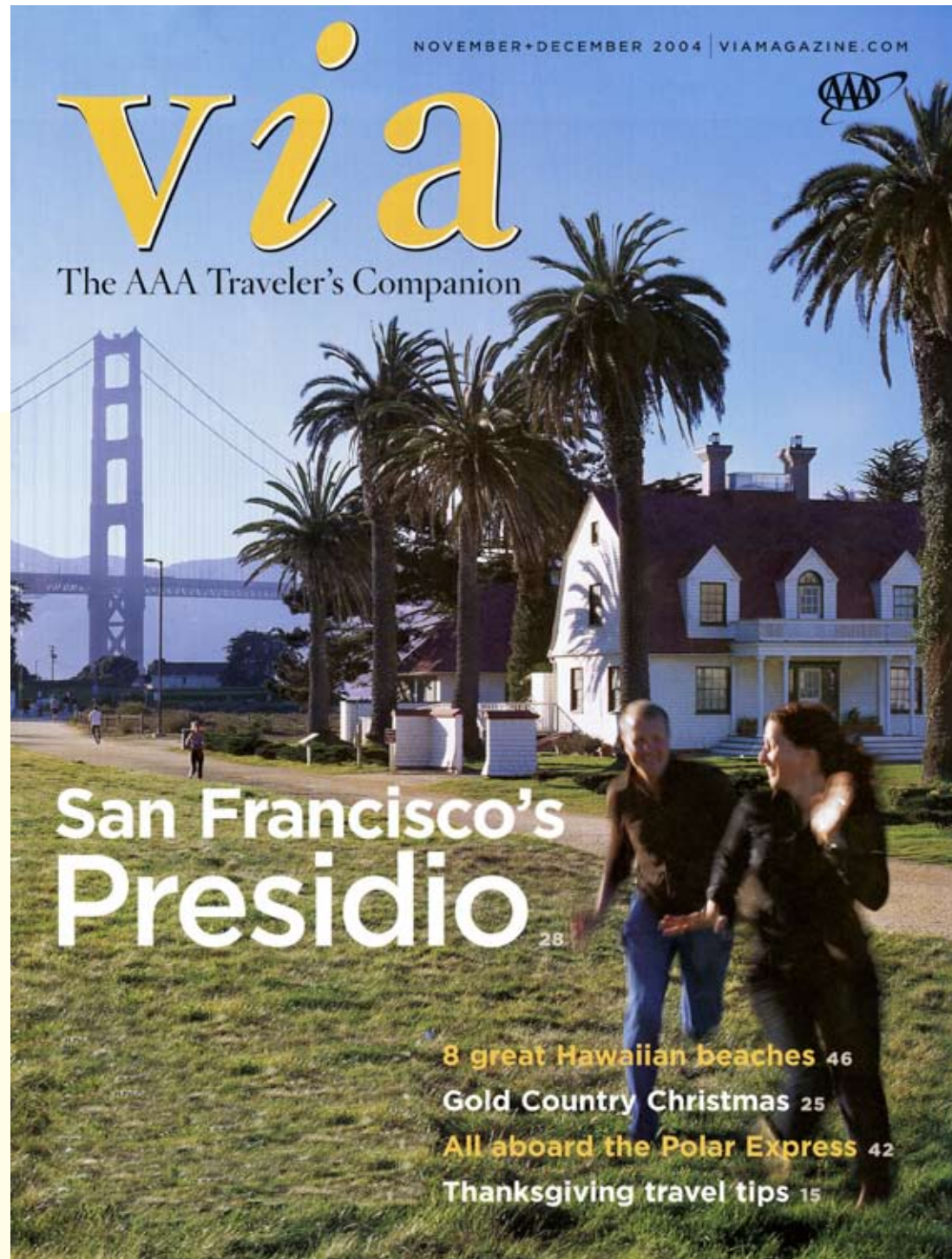

More than a quarter-million holiday and landscape lights will brighten the evening skies beginning Thanksgiving day, as the 18th-annual Holiday Lights and Open House gets under way at Shore Acres State Park in Charleston.

### *Holiday Lights go on for Thanksgiving day*

The 18th-annual Holiday Lights at Shore Acres State Park will come on at 4 p.m. on Thanksgiving day and continue daily through New Year's Day.

This walk-through display, with more than seven acres of lighted gardens, continues to attract thousands of visitors each season. The Garden House, beautifully decorated in a traditional holiday theme will have friendly volunteer hosts from many organizations, businesses and members of Friends of Shore Acres will serve hot cider, cookies, punch and coffee from 4 to 10 p.m. each night, including Christmas Eve, Christmas day, New Year's Eve and New Year's Day. Choirs, carolers and bands will offer entertainment next door in the performance pavilion. And there's plenty of

parking for both cars and buses.

This year's display also features garden landscape lighting, 20 large Christmas trees decorated by various organizations and businesses, and dozens of lighted sculptures including the Shore Acres' herons, life-size whales, an animated sea lion display, an undersea garden, flowers, garden bugs and butterflies, a leaping frog in the pond and many other surprises.

Exciting holiday gifts and raffle tickets for the "Ultimate Bed and Breakfast" are available in the Friends' Information and Gift Center. The "B&B" is an overnight stay for two adults in the Garden House on New Year's Eve with a special catered breakfast the next morning. Tickets are \$10 each (only 200 will be sold) with the

drawing to be held at 9 p.m. Christmas day. Ticket holder does not need to be present to win.

The holiday lights event became an instant community tradition in 1987 when the Friends of Shore Acres, in cooperation with Shore Acres State Park, decided to "string a few lights" to help celebrate the holidays. That first season, 6,000 miniature lights, one Christmas tree and the open Garden House drew 9,000 visitors.

Now, more than a quarter million lights — both holiday and landscaping — dozens of Christmas trees, lighted sculptures, a performance pavilion, and the beautifully decorated Garden House attract 40,000 to 65,000 visitors each season.

Inside the Garden House, long

scrolls of names pay tribute to lights pledge and business supporters and the members, volunteers and park staff who make it happen for all to enjoy — more than 1,200 all together.

Shore Acres State Park is located 13 miles southwest of Coos Bay/North Bend. Admission is a parking fee of \$3 per vehicle or a current Oregon Parks & Recreation Department annual parking permit or Coastal Passport, or a current campground receipt. The Friends welcome donations for refreshments and for continuing the event the following year. The lights of Shore Acres

Annual holiday display provides magical respite from winter

What is it about the Holiday Lights at Shore Acres State Park that attracted 47,680 visitors from 38 countries and 46 states last year?

For one thing, you get a lot more than pretty lights. It's also the setting on the bluffs, the stormy time of year, an indefinable magic as darkness descends, refreshments in the charming Garden House and entertainment by local groups, as well as a quarter million well-placed lights.

Shore Acres began as the summer home of Louis J. Simpson, pioneering Pacific Coast lumber and shipbuilding entrepreneur. His home had not only a spectacular setting on the bluffs, but five acres of gardens featuring trees, shrubs and flowering plants brought by sailing ships from around the world. During Simpson's lifetime, the public was welcome to stroll the grounds, and since 1942, Shore Acres has been a state park.

The formal gardens have grown to seven acres and are worth visiting any time of year, but their popularity soars during the holidays. Although located close to the ocean bluffs, the gardens are protected from winter storms by thick groves of tall conifers.

Winter storms are common. So

When Team Best of... set out in search of the best Christmas — er, make that "holiday" — display in the Best of... minivan, we snaked our way through all the nooks and crannies of the region looking for something that would dazzle.

We saw giant inflatable Santas on the lawns of those brand-spankin'-new northeast Eugene cul-de-sacs. We saw shopping center parking lots strung up with millions of white lights that blink to the rhythm of "Jingle Bells." We even checked out an NC-17 display on Barger Drive of illuminated reindeer doing what, um, well — they were engaged in what hot-blooded reindeer do, you know, to reproduce.

We examined everything that flashed, shined, winked,

blinked, twinkled and waved, hoping to find the ultimate in holiday cheer. And what we saw was a lot of plywood-and-lights contraptions not stimulating enough to bedazzle our cable TV/high speed Internet/video game/picture phone-saturated brains.

That is, until we followed the bright star on a midnight clear and ended up at far-flung Shore Acres State Park, near Charleston on the coast. If only Ken Kesey were alive to see it.

Not that you have to be

hallucinating to appreciate the full spectrum of 250,000 blinking, flashing, multicolored holiday lights. But you've got to admit that wandering among electrified diving sea lions and leaping frogs while sipping cider and munching on snickerdoodles would be right up the Merry Pranksters' alley.

The park's 18th annual Holiday Lights display is a family affair, which means you're far more likely to trip over a sniveling youngster than a giggling hippie. Which is just fine with Team Best of...

But about those lights.

There's an orca cresting and splashing into an imaginary ocean. The effect is created by different sets of lights, blinking one at a time, sort of like the way cartoons used to be drawn.

There are sea lions barking and diving off rocks. And an undersea garden, complete with a starfish, crab, sea horse, octopus and the dangling legs of some kind of waterfowl.

But if wildlife ain't your thing, sniff the pretty flowers. They won't smell like anything

but voltage, but have you ever seen a tulip, rhododendron, rose and dahlia in the same magnified scene?

There's a grasshopper, a snail, a turtle and a slug. Take your pick. And much, much more. Seven acres of Christmas trees, hedges and shrubbery of all kinds are jam-packed with lights.

The whole thing started back in 1987, when the Friends of Shore Acres decided to string a few lights to draw visitors to the park. The first season, it was 6,000 miniature lights, a tree and a decorated garden house.

About 9,000 people showed up.

As the years dragged on, the Friends found more and more — and more — lights. Now, some 40,000 to 60,000 visitors from 38 countries arrive each season.

There will be more than a quarter million lights, more cluster flowers, more landscape lights as we continue "framing" the garden and - as always - more surprises. ■

# Shore Acres Pond gets “base” lift - April, 2005

Since Louis Simpson first created it, the lily pond has been the scenic centerpiece of the gardens at Shore Acres. The calm waters, colorful aquatic plants, and the twin bronze cranes eternally admiring their reflections have pleased visitors for many years. As many of our readers already know, the pond — like the rest of the garden — has gone through many changes. During the early years of state park administration, the pond was filled in and used as a “sunken garden” because of leaks in the original base. It was not until the “great make-over” of 1973 that the area was fully repaired and turned back into what we see and enjoy today.

What many may not know is that for the last 10 years or so, we park staff have been struggling with a new round of leaks that slowly but surely were draining the pond. During the summer we could see the effects of the leaks by the “bathtub ring” around the edge of the pond exposed by the retreating waters. The by now almost 30 year old pond base was cracking here and there and allowing water to seep out. This was mainly due to normal deterioration but probably also due in part to unavoidable wear and tear of our annual “brush and flush” cleaning of the pond.



Nevertheless, in the last several years, we felt that we had the leak situation under control but each time we cleaned the pond, we would look for obvious cracks and repair them with various spot treatments (including a concoction whose name in the pond repair biz is “moose milk”!) which themselves stood out as off-color patches and blotches. Add rusting exposed rebar (part of the original reinforcement for the pond base) and we eventually realized that at some point we would have to consider a complete brand new resurfacing of the pond base.

Over a period of several years, the park (mainly through the efforts of assistant gardener Ellie Kinney-Martial) and the Friends of Shore Acres (FoSA) explored various options (materials and application methods) to achieve this goal. Originally, we thought the best way would be an application of “shotcrete” (a spray-on concrete-like substance used in swimming pools) but further research indicated that the weight of a new layer of such material might actually lead to further cracking of the underlying original “gunnite” surface material and possibly more leaks down the line.



# Result: A Pristine Pond Ready for Visitors

Eventually, we heard (courtesy of Mike Shott of LTM, Inc.) about a sealing material called “Tamoseal” which could be applied much thinner than the 2” or so required for the shotcrete while still providing the water-proofing we needed plus repairing the unsightly flaking of the old surface and rust stains. FoSA would generously buy the needed materials (some was also kindly donated by Mike and LTM), and we could use inmate crews from the Shutter Creek Summit Program to help Ellie and Bob Dixon (a long-term seasonal employee with formidable construction skills) to make this thing happen. We had the money, the materials, and a plan of action but as it turned out one vital thing was lacking — dry weather. The material had to be applied to a clean and dry surface. We could clean the base just as we did every year but keeping it dry was to be a real problem considering the fact that this spring turned out to be one of the wettest in recent memory — rain every day and when it held off for a few days and the surface seemed to be drying off enough to work, it would then rain again — big time frustration!



We had planned for about a week’s worth of work but with various rain delays, it took almost a month to do the prep work (grinding down the exposed rebar to bare steel, putting rust-inhibitor on it and then covering the repair with concrete to bring the treated area up to grade) plus 2 complete applications of the Tamoseal (applied with brushes and brooms with at least a 24 hours drying time between each application) to the entire pond base. We are happy to say that it was worth the wait and the work.

The pond base surface looks uniformly smooth and lovely, we came in under budget, and (believe it or not) no leaks! ■

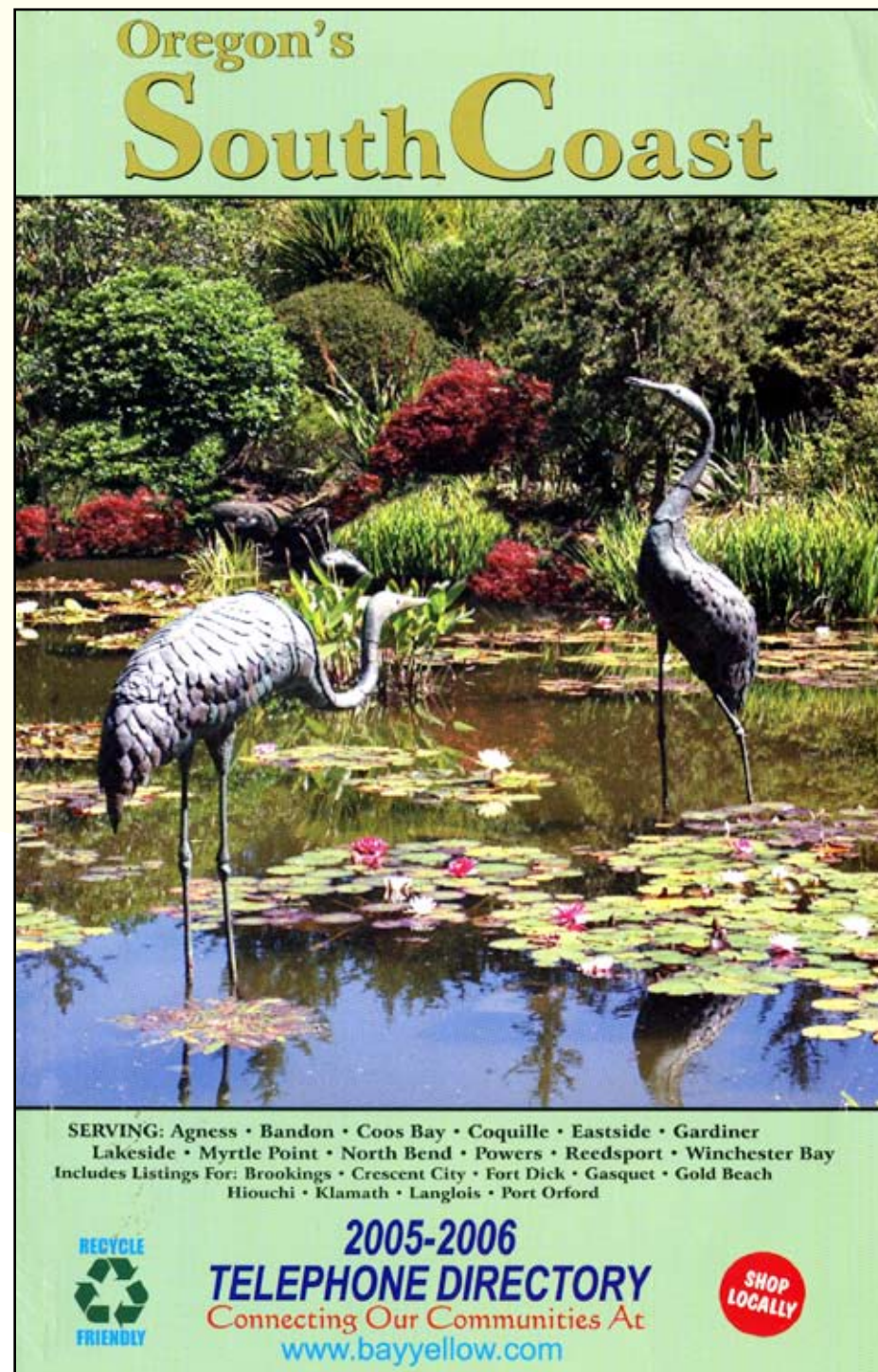

# Cape Arago Highway Repairs and News in 2005

## Parks commission mulls cape highway ownership

The Oregon Parks and Recreation Department may soon own some highway in Coos County.

The State Parks Commission is scheduled to decide this week whether the department will take control of a section of the Cape Arago Highway as it meanders through Shore Acres and Cape Arago state parks. The commission, which holds meetings at various spots around the state eight times annually, will meet for its summer meeting in Brookings on Thursday.

The highway proposal is tied to several changes for State Parks on the South Coast, according to Andy LaTomme, the agency's area manager. At one time, the Oregon Department of Transportation and State Parks were one agency, he explained. When they split, the properties didn't necessarily go to the proper agency. Now, ODOT wants State Parks to be responsible for roadways within its properties.

The prospect of taking ownership of the highway is not without risk, since slides have closed or hampered access to Cape Arago State Park over the years. Parks officials say ODOT has worked to upgrade the road into the park to prevent slides in anticipation of the ownership change. Ultimately, should the road slide again, State Parks officials say the agency would be responsible for repair, with ODOT engineering and design aid.

Land exchanges also are in the works in Curry County. Plans also call for State Parks to take over responsibilities along an almost 3-mile stretch of roadway at Cape

Blanco State Park. The agency will take ownership of the Ophir Rest Area and will add 36 acres to its holdings at Otter State Park, a couple miles north of Gold Beach.

"It will give us a piece of ocean-front property at Otter Point that is contiguous," he said.

Currently, ODOT owns that property, too. While the Otter Point access area is primitive with a gravel parking lot, there are no plans to improve the entrance road or the parking area at this time, he said.

In exchange for the added lands and roads, State Parks plans to deed over to ODOT a 19-acre parcel near Prineville where a highway was upgraded.

While traveling down the South Coast today, OPRD commissioners are to tour of a new welcome center at Shore Acres State Park at 11 a.m. Also, the commission is scheduled to stop at the South Slough National Estuarine Research Reserve near Charleston.

On Thursday, the commission's Brookings meeting is scheduled to start at 9 a.m. at the Beachfront Inn, 16008 Boat Basin Road.
