## Shore Acres State Park – Special Activity Regulations

Thank you for considering Shore Acres State Park for your special activity. The following regulations help ensure your event runs smoothly and that the park remains in excellent condition for all visitors.

### General Requirements

- Reservations may be made up to **nine months** in advance.
- Applicants must be **18 years or older**, obtain the permit, and remain on-site for the duration of the activity.
- Only the individuals listed on the application may make changes, cancel the permit, or access permit information.
- All event activities, including cleanup, must be completed **one hour before park closing**. Contact Shore Acres State Park at 541-888-3732 to confirm closing time for your event date.
- Activity permits are **non-exclusive**. All areas normally open to the public remain accessible to park visitors, including your event site.
- All participants must comply with **State Park Rules** and these Activity Regulations.
- **Animals are not allowed** in Shore Acres State Park.
- A copy of the signed activity application/permit must be with you during your event.
- All vehicles must display a valid day-use parking permit.
- Candles, flames, oil lamps, and other combustibles are not permitted.

### Decorations, Furniture, and Site Use

- All decorations must be **freestanding**. Nothing may be attached to park structures or plants.
- Chairs and tables are limited to specific types and designated areas. The park does not provide chairs or tables. Refer to the Garden Map for allowable placement.
- The following activities are not allowed:
  - Throwing or releasing any objects
  - Walking or standing in flower beds
  - Loud noise or loud music (see music guidelines below)

### Music and Sound

- If you plan to have music, indicate this on the application and briefly describe the type and delivery method.
- Music must be appropriate for the intimate and serene garden setting.
- **Not allowed:** DJs, amplified sound, microphones, bullhorns, percussion instruments, or live amplified bands.
- State Parks may terminate any sound deemed excessive or disruptive to other visitors.
- Contact the park office in advance for additional information.

### Food, Beverages, and Alcohol

- Serving food or beverages is permitted **only with Package #1 or #2**.
- BBQ grills require preapproval and may be used only in designated areas.
- If alcohol will be served, indicate this on the application. Alcohol is allowed in accordance with state laws regarding age, distribution, and behavior.
- Smoking is not permitted anywhere in the park except inside your personal vehicle.

### Cancellations, Changes, and Refunds

- **Cancellations:**
  - Must be submitted in writing at least one month before the activity date.
  - A **\$10 cancellation fee** applies.
  - If cancellation is received less than one month before the event, the facility deposit equal to one day's rental is forfeited.
  - The cleaning/damage deposit will be refunded.
- **Changes to the Permit:**
  - Must be submitted in writing at least one month before the event.
  - A **\$10 processing fee** applies.
- **Deposit Refund:**
  - If no damage or cleanup is required, a full refund will be issued within 60 business days after the event.
  - You will be notified in writing within 60 business days if a full refund cannot be issued.
  - Refunds are mailed to the name and address of the person who paid by check or credited back to the original card.
